Mr. Farrall presented the rezoning application and discuss the fact that Bensalem Township was "cleaning up" the zoning along State Road and fixing the problems of the past. The rezoning will help the developer of the gas station because some of the uses they are proposing would confirm to the GC zoning and not to the LI zoning. Frank Schilling had additional questions as to why there was a need to do this, Mr. Farrall discussed other parcels that the Township has rezoned in an effort to fix the problems on State Road. 2. Bensalem Township Certified Redevelopment Area - Existing Conditions Report.

Mr. Farrall presented the Bensalem Township Certified Redevelopment Area on Existing Conditions Draft Report, dated July 2023. Mr. Farrall presented this will establish the redevelopment area for tax incentives or possibility of special financing through the Bucks County Redevelopment Authority. The area included the Route 1 corridor up to and including the Neshaminy Mall. This area was picked due to the existing hotels that the police have had problems with and numerous vacant properties. Ed Tokmajian, Sr, had numerous questions, including who would develop the properties and what would be put on the properties. Mr., Farrall discussed the incentives would go to a developer who is investing in the property to develop. The incentives would not just be a payment to the property owner unless the property is developed in conformance with Township Ordinances. No formal plans have yet to be submitted by a developer.
